

What is a Quality Management Plan? Why Should You Care?

• The Project Management Institute's Body of Knowledge (PMBOK®) calls for a Quality Management Plan as part of the Competency Maturity Model Level 3. It describes the process framework (e.g., Agile or Lean) for your project and specifies the methodologies, plans and control activities associated with the approach chosen. Be proactive and anticipate your PM's need for such a document. At least be party to its creation, refinement and implementation. Spell out all standards, regulations and laws that may affect your quality efforts. Learn how Quality Management fits in with complementary parts of the PMBOK, such as Configuration Management, Risk Management and Communication Management. Use this plan to get buy-in from management for the approach you wish to use. Act sooner, rather than later or risk having your hands tied by the time your project gets under way.
